

MetaEdit+[®] Workbench Introductory for Windows

SOFTWARE LICENSE AGREEMENT

IMPORTANT: PLEASE READ THIS CAREFULLY BEFORE OPENING THE SOFTWARE PACKAGE AND/OR USING THE SOFTWARE.

This is a legal agreement between you, the End-user and MetaCase Consulting, from the City of Jyväskylä, Finland (“Licensor”). By installing and/or using any portion of the delivered package, you are agreeing to be bound by the terms and conditions of this agreement. If you do not agree to the terms of this agreement, you must return the unopened software package and the accompanying items (including all material received) within eight (8) working days to the firm from which you obtained them for full credit. All the rights and warranties governing MetaEdit+ Workbench (hereafter referred to as the “Software”) are stated in this agreement.

1 License Granted

The Licensor grants you a limited right to install and use one copy of the Software in accordance with this License Agreement. You may use the Software in any compatible computer that you own, lease or otherwise control, provided that at any given time the Software is only installed in one computer and used in one computer. You are responsible for obtaining any further license that may be necessary to provide the computing environment required by the Software, such as the operating system license. You hereby agree that all rights not expressly granted herein, including without limitation copyright and any other applicable intellectual property right as well as the title to or interest in the Software, media on which the Software is supplied, and any other material delivered with the Software such as any User Manuals, are and shall remain with the Licensor. This Software and any other material delivered with it are owned by the Licensor, and the Software as well as such material are protected by copyright laws, international treaty provisions, and all other applicable national laws of Finland. This agreement only gives you a limited, non-exclusive right of strictly internal use, which is revocable in accordance with this License Agreement. You agree that you will not assign, sublicense, transfer, pledge, lease, rent or share your rights under this License Agreement. Furthermore, you will not use the Software nor those metamodels or models included in the repository provided in the Software for any purpose other than for the purposes specified in the User Manual delivered with the Software, nor in any way other than as specified in the said User Manual. In particular, the usage of the said metamodels or models in any way other than in combination with the Software is strictly prohibited. You may not transfer your rights to a third party without a prior express written permission from the Licensor. In the case of such a transfer you must pass all material received to the approved third party, and any backup copy in your possession must be erased or otherwise destroyed.

2 Backup Permission and Reverse Engineering Prohibition

You may make any number of copies of the Software solely for backup or archival purposes. You must reproduce and include the copyright notice appearing on the media on which the Software is supplied on all copies of the Software. You may not copy any other material delivered with the Software, such as any written or printed materials. You may not reverse engineer, decompile, or disassemble (or in any similar manner examine the internals of) the Software, with the exception of examining the metamodels and models included in the repository with the metamodeling and modelling tools provided in the Software for the sole purpose of using those metamodels and models for the purposes specified in the User Manual delivered with the Software. Should you need information concerning the information interfaces of the Software necessary for reaching interoperability between the Software and any other software, such information shall be provided to you upon written request within reasonable time. Such information shall be considered as material supplied with the Software for the purposes of this License Agreement.

3 Multiple-media Software

You may receive the Software in more than one medium. Regardless of the type or size of medium or media you receive, you may use only one medium that is appropriate for your single computer. You may not use or install the Software on such other medium on another computer.

4 Non-Disclosure

The Software and any other material delivered with it shall be defined as a confidential business secret of the Licensor and treated as such. A disclosure of the Software or any other material delivered with it to a third party without a prior express written permission from the Licensor is strictly prohibited. You shall take all necessary precautions to maintain the confidentiality of the Software; these precautions shall be at least equivalent to those employed by your organisation to protect its own business secrets and other confidential information. You shall limit the access to the Software and any other material delivered with it to those of your personnel for whom such access is reasonably necessary for the proper

performance of their tasks and for the permitted form of usage of the Software and any other material delivered with it under this License Agreement. You may not distribute the Software, any other material delivered with it or any passwords you receive to a third party. This section shall survive any termination or expiration of this License Agreement for whichever reason.

5 Limited Warranty

The Licensor warrants that the delivery media (if CD), in which the Software is embedded, shall, for a period of ninety (90) days from the day of commencement of this License Agreement (referred to as the Warranty Period), be free from defects in material and workmanship. The Licensor further warrants that during said Warranty Period, the Software shall operate substantially in accordance with the functional specifications given in the User Manual delivered with the Software. If, during the Warranty Period, a defect in materials appears, and the defect is not caused by accident or misuse, you may return the materials to the firm from which you obtained them from either for replacement or, if so elected by the Licensor, a refund of the amounts paid by you under this License Agreement. If, during the Warranty Period, You demonstrate to the Licensor that the Software shall not operate substantially in accordance with the functional specifications given in the Software User Manual delivered with the Software and such defect is not caused by a modification performed by someone other than the Licensor, the Licensor shall have the option, at its sole choice, of either (a) modifying the Software so that it operates as required, or (b) giving you instructions on how the Software can be made to perform as required without any modifications, or (c) terminating this License Agreement and returning the license fee paid to the Licensor for the use of the Software. Furthermore, the Licensor guarantees that the Software does not infringe any patent, copyright or other intellectual property rights enforceable in Finland or any other country expressly nominated in writing by the Licensor. If an action is brought against you for an infringement of the rights referred to above, you must inform the licensor of such an action immediately. If the Infringement is deemed to be final, the licensor shall, at its own choice, (i) see that you are granted the right to use the Software, (ii) change the Software so that the infringement will no longer exist or (iii) take back the Software and, refund you with the license fee paid to the Licensor for the use of the Software. This clause shall exhaustively cover the Licensor's rights for intellectual property rights infringements. You will promptly inform the Licensor of any intellectual property right infringements you detect. The Licensor does not warrant the fitness, usability or merchantability of the results achieved by the Software.

6 Other Warranties

Except for the warranties set forth in paragraph 5 of this License agreement, the materials and the Software contained therein are licensed "as is", and the Licensor disclaims any and all other warranties, whether express or implied, including (without limitation) any implied warranties of usability, saleability, intellectual property non-infringement or fitness for a particular purpose. All warranties shall be void, if the error in the Software or its part is due to an accident, misuse or incorrect installation of the Software or its part or if the error only occurs when the Software is used in connection with other software.

7 Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL THE LICENSOR OR ITS SUPPLIERS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT, CONSEQUENTIAL, PUNITIVE OR EXEMPLARY DAMAGES WHATSOEVER (INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF GOODWILL, BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, OR ANY OTHER PECUNARY LOSS) ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE OR THE PROVISION OF OR FAILURE TO PROVIDE SUPPORT SERVICES, EVEN IF THE LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN ANY CASE, THE LICENSOR'S ENTIRE LIABILITY UNDER ANY PROVISION OF THIS AGREEMENT SHALL BE LIMITED TO THE GREATER OF THE LICENSE FEE PAID TO THE LICENSOR FOR THE USE OF THE SOFTWARE OR U.S.\$5.00.

8 Severability and Waivers

Should any term or part of a term of this License Agreement be declared void or unenforceable by any court of competent jurisdiction, such a declaration shall have no effect on the remaining terms or parts of terms herein. No failure to exercise, nor any delay in exercising, on the part of the Licensor, any right or remedy hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or remedy prevent any further or other exercise thereof or the exercise of any other right or remedy.

9 Jurisdiction

All parties will not be bound by any statements other than those included in this copy of the Agreement. This License Agreement shall be construed as under and governed in accordance with the laws of the Finland. Both parties agree that any disputes arising out of this License Agreement or its interpretation shall be finally settled in arbitration by a single arbitrator in accordance with the Rules of the Arbitration Committee of the Finnish Central Chamber of Commerce pursuant to the regulations in force. The arbitration shall be conducted in Jyväskylä, Finland.

10 Customer Service and Future Releases

This License Agreement does not entitle you to any customer support, service and maintenance other than as expressly provided for in this License Agreement, as they are agreed upon and priced separate from this License Agreement. This License Agreement does not entitle you to further releases of the Software.

11 Termination

Without prejudice to any other right, the Licensor may terminate this License Agreement with immediate effect if you fail to comply with terms or conditions of this License Agreement. In such event, you must immediately cease to use the Software in any way, destroy all copies of the Software and return all material received to the Licensor.

YOU ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT, UNDERSTAND IT AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. YOU FURTHER AGREE THAT IT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF THE AGREEMENT BETWEEN YOU AND METACASE CONSULTING AND SUPERSEDES ANY EARLIER PROPOSAL OR PRIOR ARRANGEMENT, WHETHER ORAL OR WRITTEN OR IN ANY OTHER FORM.
